The novel is set against the backdrop of the turmoil leading to the 1947 Partition. It examines the lives of women whose experiences are profoundly shaped by events yet remain confined within the domestic sphere. *The Women's Courtyard* looks at how women are affected by the Partition. Scholars have analyzed the novel through critical frameworks such as feminism, postcolonialism, trauma studies and gender studies. These studies highlight the novel's significance in understanding the experiences of women during the Partition.

A significant area of debate focuses on Mastoor's depiction of women as victims of both patriarchal systems and political instability. Multiple scholars have analyzed Aliyas character as a symbol of consciousness amid a period of social and political change.

Aliyas observations enable readers to witness the evolution of family dynamics, gender roles and political allegiances. Critics contend that her evolution mirrors the fight of women striving for independence within confining societal frameworks. The topic of agency has garnered significant scholarly attention. Scholars have examined how Masturs female protagonists defy conventions through their speech, decisions and acts of resistance. Although The Womens Courtyard has been extensively researched regarding feminism and the Partition there is still potential for further investigation into the psychological trauma endured by women during that period. This study aims
